WEBSITE TERMS OF USE

These Terms and Conditions, together with any and all other documents referred to herein, set out the terms of use under which you may use this website, www.southdevonrailwayassociation.org ("Our Site"). Please read these Terms and Conditions carefully and ensure that you understand them. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of Our Site. If you do not agree to comply with and be bound by these Terms and Conditions, you must stop using Our Site immediately.

1. Definitions and Interpretation

1.1 In these Terms and Conditions, unless the context otherwise requires, the following expressions have the following meanings:

"Content" means any and all text, images, audio, video, scripts, code, software, databases and any other form of information capable of being stored on a computer that appears on, or forms part of, Our Site; and

"We/Us/Our" means South Devon Railway Association Limited, a company limited by guarantee, registered in England under 10710863, whose registered and main trading address is The Railway Station, Dartbridge Road, Buckfastleigh, Devon, TQ11 0DZ.

2. Information About Us

1.1 Our Site, www.southdevonrailwayassociation.org, is owned and operated by South Devon Railway Association Limited, a company limited by guarantee, registered in England under 10710863, whose registered and main trading address is The Railway Station, Dartbridge Road, Buckfastleigh, Devon, TQ11 0DZ [Our VAT number is 281 9242 47 .]

3. Access to Our Site

- 1.1 Access to Our Site is free of charge.
- 1.2 It is your responsibility to make any and all arrangements necessary in order to access Our Site.
- 1.3 Access to Our Site is provided "as is" and on an "as available" basis. We may alter, suspend or discontinue Our Site (or any part of it) at any time and without notice. We will not be liable to you in any way if Our Site (or any part of it) is unavailable at any time and for any period.

- 2.a.8 misleadingly impersonates any person or otherwise misrepresents the identity or affiliation of a particular person in a way that is calculated to deceive (obvious parodies are not included in this definition provided that they do not fall within any of the other provisions of this sub-Clause 5.4);
- 2.a.9 implies any form of affiliation with Us where none exists;
- 2.a.10 infringes, or assists in the infringement of, the intellectual property rights (including, but not limited to, copyright, trade marks and database rights) of any other party; or
- 2.a.11 is made in breach of any legal duty owed to a third party including, but not limited to, contractual duties and duties of confidence.
